Specialist in the field of labour law and industrial relations, also in the comparative dimension, as well as EU labour law and antidiscrimination law.

Her most recent works concern the changes in labour law and collective bargaining systems following the austerity measures adopted in Europe,

as well as the process of implementation of transnational collective agreements in multinational companies and their global supply chains.

She studied new objects and modes of governance, especially the open method of coordination in the employment and social protection fields and the fundamental social rights. In the 2013 she coordinated a European project on international industrial relations, focusing on the Mediterranean countries (Spain, France, Italy, Turkey). She qualified in the field of information and consultation rights and European works councils; in the European company law, especially in the worker's involvement at the European company level; in the European social dialogue and the transnational collective bargaining.

In relation to antidiscrimination law, she has been analysing the new European and national legal framework on equal treatment and notably the equality bodies, the use of non-discrimination model by Courts.
